- I. In order to attract outstanding international students (including overseas Chinese students and students from Hong Kong and Macau, but excluding those in the Overseas Chinese Student Program) to study at Chien Hsin University of Science and Technology (hereinafter referred to as "the University"), and to help alleviate their living expenses during their studies, the University has specially established the Chien Hsin University of Science and Technology International Student Scholarship Guidelines (hereinafter referred to as "these Guidelines").
- II. The term "international students" as used in these Guidelines refers to students admitted in accordance with the "Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students Returning to Taiwan," the "Regulations Regarding Hong Kong and Macau Residents Studying in Taiwan," and the "Regulations Regarding International Students Undertaking Studies in Taiwan" during the semester of admission.
- III. All international students enrolled in the University's undergraduate (day division), master's, International Special Program, and International Industry-Academia Collaboration Program (excluding students with dual nationality including ROC nationality, extended study students, and those in the Overseas Chinese Student

Program), who have not received domestic or foreign government scholarships or other Ministry of Education scholarships, may apply.

- IV. The Office of International Cooperation will review the relevant supporting documents, and the list of approved applicants will be submitted for special approval according to the student category.
- V. Foreign students who meet the following eligibility criteria may apply to the Office of International Cooperation within the specified period:

(1) Regular students

- 1. First semester of the first academic year for new students: Completion of enrollment procedures.
- 2. Second semester of the first academic year for current students: The average academic grade for the previous semester must be 75 or above, conduct grade must be 80 or above, and absences must not exceed one-fifth of the total class hours.
- 3. First semester of the second academic year and thereafter for current students: The average academic grade for the previous semester must be 75 or above, Chinese proficiency test level B1 or above, conduct grade must be 80 or above, and absences must not exceed one-fifth of the total class hours.

(2) International Special Program Students

- 1. First semester of the second academic year (first semester of the first academic year for undergraduate students): Completion of enrollment procedures.
- 2. Second semester of the second academic year (second semester of the first academic year for undergraduate students): The average academic grade for the previous semester must be 75 or above, conduct grade must be 75 or above, and absences must not exceed one-fifth of the total class hours.
- 3. First semester of the third academic year and thereafter (first semester of the second academic year for undergraduate students and thereafter): The average academic grade for the previous semester must be 75 or above, Chinese proficiency test level B1 or above, conduct grade must be 75 or above, and absences must not exceed one-fifth of the total class hours.

(3) International Industry-Academia Collaboration Program Students

- 1. First semester of the first academic year for new students: Completion of enrollment procedures.

2. Second semester of the first academic year for current students: The average academic grade for the previous semester must be 75 or above, conduct grade must be 75 or above, and absences must not exceed one-fifth of the total class hours.
3. First semester of the second academic year and thereafter for current students: The average academic grade for the previous semester must be 75 or above, Chinese proficiency test level B1 or above, required internship course grade must be 70 or above, conduct grade must be 75 or above, and absences must not exceed one-fifth of the total class hours.

#### (4) Chinese Language Preparatory Program Students

1. First academic year: Completion of enrollment procedures.
2. • The application period and disbursement time for this scholarship are as follows:
  - (1) For students in the Mandarin Pre-sessional Program, second-year first-semester students of the International Special Program, and new students, applications should be submitted by the Office of International Cooperation according to the student category and roster.
  - (2) Returning students must apply within one month after the start of each semester.

However, in special circumstances, the actual dates will be based on the announcements made by the Office of International Cooperation. Late applications will not be accepted.

The scholarship will be disbursed in the 13th week of each semester; however, in special circumstances, the actual date will be based on the announcements made by the Office of International Cooperation.

#### VI. The application period and disbursement time for this scholarship are as follows:

- (1) Students in the Mandarin Preparatory Program, second-year first-semester students in the International Special Program, and new students shall apply through the Office of International Cooperation of the university according to student category and the designated list.
- (2) Returning students must submit their applications within one month after the start of each semester.

However, in special circumstances, the actual dates will be based on the announcements made by the Office of International Cooperation. Late applications will not be accepted.

The scholarship will be disbursed in the 13th week of each semester.

However, in special circumstances, the actual date will be based on the announcements made by the Office of International Cooperation.

VII. Applicants for scholarships and grants must submit the following supporting documents:

(1) For students in the Chinese Language Preparatory Program, second-year first-semester students in the International Specialized Program, and new students: one copy of the admission application form, proof of academic transcripts from the highest level of education attained, and a photocopy of the passport.

(2) For returning students: one copy of the previous semester's academic transcript, a photocopy of the Chinese language proficiency test certificate, a photocopy of the student ID (with the current semester's registration stamp), and records of absences. Amount and Items of Scholarship Subsidy are as follows:

(1) Freshmen in their first semester of the first academic year and students in the International Special Program in their first semester of the second academic year will receive a 50% reduction in tuition and miscellaneous fees.

(2) Returning students will receive a reduction of NT\$12,000 in tuition and miscellaneous fees each semester.

(3) Mandarin Pre-sessional Class: A reduction of NT\$24,000 in Mandarin course fees will be granted for the first academic year.

(4) Freshmen in their first academic year and students in the Mandarin Pre-sessional Class will receive a full waiver of accommodation fees (including winter and summer breaks).

(5) Scholarships for students in special programs and international exchange students may be processed upon approval by the President on a case-by-case basis.

VIII. If foreign students encounter special circumstances related to work or life, the Office of International Cooperation may submit a special request to the President for approval to apply for relevant scholarships.

IX. The circumstances under which scholarship recipients may have their qualifications revoked are as follows:

(1) If a scholarship recipient is found to have engaged in forgery or provided false information, their scholarship eligibility shall be revoked, and the scholarship funds must be returned.

(2) If a scholarship recipient commits a serious violation after receiving

the scholarship, their eligibility for the scholarship in the following semester shall be cancelled.

- X. These operational guidelines apply to foreign students admitted from the 2025 academic year onwards.
- XI. These operational guidelines shall be implemented upon approval by the Scholarship Review Committee and ratification by President; the same procedure shall apply to any amendments.
